- 2. The bid for the work shall remain valid for a period of **180 days** from the date of Opening of Cover-II.
- 3. The complete bidding process shall be online. The Financial bid of only qualifying bidders shall be opened online in the Office of the Executive Engineer PWD (R&B) Mechanical Division Central Kashmir after evaluation of technical bid and decision thereof.
- 4. Bidder shall be penalized as per tender conditions if they withdraw their bid during the period of bid validity or make any modifications in the terms and conditions of the bid.
- 5. Bidders are advised not to make any change in BOQ (Bill of Quantities) contents. In no case they shall attempt to create similar BOQ manually.
- 6. The cost of tender documents is non-refundable and the tender shall in no case be accepted if submitted by any firm other than the purchaser.
- 7. Conditional tenders shall not be entertained.
- 8. The Allotment Order shall be issued only after receipt of funds from the intending Department.
- 9. **Unbalanced Bid**: In case, bid of the lowest bidder is found unbalanced i.e the bidder has uploaded below percentage bid against the advertised cost, the successful bidder shall have to produce additional performance security in shape of CDR/FDR/BG within 07 days after opening of price bids as per following break up: -
